# Kentucky Outstanding Civic Education Leadership Award

## 2013-2014 Guidelines and Criteria

### Co-Sponsored by:

- Office of Kentucky Secretary of State
- Administrative Office of the Courts
- Kentucky Department of Education

**Frequency:** Annual

### Award:

- \$500 awarded to Kentucky Outstanding Civic Education Leader to be used for resources or equipment for school or civic organization
- Commemorative gift/plaque for 16 regional finalists
- Awards will be given during the KHSAA Men's Basketball Sweet 16 Tournament in Lexington, KY, date and time TBA (finalists and award winner are encouraged to attend).

**Purpose:** To recognize a P-16 teacher, school administrator, educational leader, legislator, or community organization leader who has made notable contributions toward promoting or implementing civic learning to prepare students to be engaged and responsible citizens.

### Criteria:

- Demonstrated outstanding leadership in classrooms and/or the community by promoting and strengthening high-quality civic education practices through instruction, programming, research, advocacy, and/or legislation in Kentucky. High-quality P-16 civic education practices are characterized by:
  - instruction in government, history, law and democracy
  - discussion of current local, national, and international controversial issues and events in classrooms and/or the community
  - opportunities for students to engage in simulations, service-learning projects or other real world applications of democratic process and procedures
- Demonstrated ability to foster the development of democratic beliefs and values, skills and dispositions needed for citizen participation appropriate to students' grade level in classroom, school, and community settings.

**Eligibility:** Currently perform work relevant to P-16 students in the Commonwealth.

### Application/Nomination Requirements:

- **Cover Page**
- **Letters of Support:** Two letters supporting your application/nomination.
- **Curriculum vitae or professional resume:** Maximum three pages, including dates of applicant/nominee's offices, committee posts or other professional roles.
- **Narrative:** Describe how the applicant/nominee meets the criteria, 1-2 pages, 12-point font, double spaced, 8.5 x 11 paper.
- **Supporting Documentation (Optional):** Up to ten one-sided pages of documentation that supports the Narrative. Evidence might include clear reproductions of newspaper articles, lesson plans, student work samples, professional presentations, publications, and/or written testimonials.
- **Publicity Outreach:** Please provide the name, contact name, title, and e-mail for:
  - Major local/community newspaper (up to two)
  - Direct supervisor
