

Kentucky Voter Bill of Rights

VOTER'S BILL OF RIGHTS

Each registered voter in this state has the right to:

- 1.) Vote and have his or her vote accurately counted.
- 2.) Cast a vote if he or she is in line at the official closing of the polls in that county.
- 3.) Ask for and receive assistance in voting.
- 4.) Receive up to two replacement ballots if he or she makes a mistake prior to the ballot being cast.
- 5.) An explanation if his or her registration or identity is in question.
- 6.) Instructions to follow when voting.
- 7.) Vote free from coercion or intimidation by election officers or any other person.
- 8.) Vote on a voting system that is in working condition and that will allow votes to be accurately cast.

VOTER RESPONSIBILITIES

Each voter in this state should:

- 1.) Familiarize himself or herself with the candidates and issues.
- 2.) Maintain with the County Clerk a current address.
- 3.) Know the location of his or her polling place(s) and hours of operation.
- 4.) Bring photo identification to the polling place.
- 5.) Treat precinct workers with courtesy.
- 6.) Respect the privacy of others.
- 7.) Report any problems or violations of election laws to the Election Fraud Hotline at 1-800-328-VOTE (8683).
- 8.) Ask questions if needed.
- 9.) Make sure that his or her completed ballot is correct before leaving the polling place.

Important Dates

April 4, 2026 - Mail-in absentee request portal open

April 20, 2026 - Last day to register to vote for the primary election

May 5, 2026 - Last day to request mail-in absentee ballot

May 14, 2026 - Early in-person absentee voting (Hours vary by county)

May 15, 2026 - Early in-person absentee voting (Hours vary by county)

May 16, 2026 - Early in-person absentee voting (Hours vary by county)

May 19, 2026 - 2026 Primary Election Day - Hours of Voting: 6 a.m. to 6 p.m., prevailing time. At 6 p.m., the Precinct Sheriff goes to the end of the line and stays there until everyone in front of him/her has voted. Anyone in line by 6 p.m. is given the opportunity to vote.



Become a Poll Worker

Our free and fair elections depend on Kentuckians taking the initiative to play an active role. The Commonwealth of Kentucky is calling on civic-minded individuals to work the polls.

Registered Independents, Democrats and Republicans can all serve!

To participate:

- You must be a registered voter and a resident of the county in which you wish to work.

- You must be 18 years old (or turn 18 by the General Election).

Poll workers earn money for their service! Amount depends on the county.

Voting Equipment

- The State Board of Elections certifies voting machines that can be sold in Kentucky. Voting machines are purchased by the county fiscal court.
- Every polling location has a voting machine accessible to individuals with disabilities.
- For a detailed listing of voting machines by county, please visit elect.ky.gov.
- The County Board of Elections has the discretion to choose which voting

equipment to use, as long as the requirements of state and federal law are met.

- Voting equipment that tabulates or aggregates votes used in official results is prohibited from connecting to any network, including the Internet, or communicating with any device external to the voting system. It is a felony to connect a voting machine to the internet.



Ways to Vote

There are several ways for a Kentucky citizen to vote. You can:

- Vote in person on Election Day.
- Vote in person early absentee the Thursday, Friday or Saturday before Election Day (no excuse needed!).
- Vote excused absentee by mail.
- Vote excused, in-person absentee .

In addition, there are provisions for Military and Overseas Voters. If there are problems at your polling place, you can vote a provisional ballot. Please visit govote.ky.gov to request an absentee ballot or check your voter status.

REPORTING VOTER INTIMIDATION AND OTHER UNLAWFUL CONDUCT

Voter intimidation is defined under the law as the use of threats, coercion or attempts to intimidate for the purpose of interfering with the right of another person to vote or to vote for the person of their choosing. Voter intimidation can include physically blocking polling places, disrupting or interrogating voters, spreading false information about voting requirements and procedures. This list is not exhaustive.

If you witness voter intimidation or other unlawful conduct at the polls, we recommend the following steps:

- Inform a precinct officer at the voting location, who will work to resolve any problems and call county election officials and/or local law enforcement if needed. However, if you or anyone else is in immediate danger, call 911 first and then inform a poll worker if possible.
- Document what you see as much as possible, including the who, what, when and where of the incident (keeping in mind the prohibited action of photographing a voter within the voting room).

Report the incident to the Election Fraud Hotline at 1-800-328-VOTE (8683). We will follow up with county election officials and federal, state or local law enforcement entities if needed.

Kentucky's Photo ID Law

Kentucky law requires that voters present a photo ID to verify identity prior to signing the electronic poll book and casting a ballot.

WHAT IS CONSIDERED A VALID PHOTO ID TO VOTE?

“Proof of identification” is defined in KRS 117.011(18), as amended. A valid ID to vote, is a document issued by:

- The United States or the Commonwealth of Kentucky;
- The United States Department of Defense, a branch of the uniformed services, the Merchant Marines, or the Kentucky National Guard;
- A public or private college, university, or postgraduate technical or professional school located within the United States;
- Any city government, county government, urban-county government, charter county government, consolidated local government, or unified local government, which is located within this state,

If the document contains: 1. The name of the individual to whom the document was issued; and 2. A photograph of the individual to whom the document was issued.

WHAT IF I DON'T HAVE OR CAN'T GET A PHOTO ID?

Kentucky law provides a free state-issued ID card for individuals who are at least 18 and do not have a valid driver's license.

In addition, voters who cannot obtain a photo ID can sign an Oath (stating reason for inability to obtain photo ID) and present one of the following non-photo IDs:

- Social Security Card;
- Any ID issued by a county in KY that's been approved by the State Board of Elections and shows voter's name;
- Any ID card with both the voter's photograph and name;
- Any food stamp ID card, electronic benefit transfer card, or supplemental nutrition assistance card issued by KY that shows voter's name; or



Information to Know

Electioneering

- No person shall electioneer at any polling place that is being used as a voting location on the day of any election, as established in KRS 118.025, or on any of the days that in-person absentee voting is conducted at that location, or within a distance of one hundred (100) feet of any entrance to a building in which voting is conducted if that entrance is unlocked and is used by voters on any primary or election day or on any of the days that in-person absentee voting is conducted
- No person shall electioneer within the interior of a building or affix any electioneering materials to the exterior or interior of a building where the county clerk's office is located, or any building designated by the county board of elections and approved by the State Board of Elections for any time voting is being conducted in the building.
KRS 117.235

Who is allowed in the Voting Room?

- Precinct Election Officers
- Voters
- Anyone assisting a voter
- Voting machine technicians
- A minor child accompanying a voter
- Duly appointed challengers
- Law enforcement officers
- Representatives conducting mock elections

Media in the Voting Room

Members of the news media may be in the voting

room for the limited purpose of filming the voting process. The media MAY NOT, however, conduct interviews with voters inside the voting room, record the identity of voters, or otherwise disrupt the voting process.

Voter Assistance

Voters with a physical disability, blindness or inability to read English may request voting assistance at the polls on Election Day. An employer, an employee's agent or an officer or agent of a union MAY NOT assist a voter. You may apply for permanent voting assistance.

Challengers

Each county political party may designate up to 2 challengers in each precinct in the county. Non-partisan candidates may designate 1 challenger.

- Challengers must receive training
- Challengers may question the eligibility of a voter for the following reasons: is not a duly registered voter; is not a resident; is a convicted felon, is not the persons he/she claims to be.
- Challengers shall not: speak directly with a voter being challenged; electioneer, handle election material, attempt to intimidate or harass any voter or precinct election officer; behave in a manner to disrupt activities; attempt to interfere with the election.

A senator must be at least 30 years old, a citizen of Kentucky, and must have lived in the state at least six years immediately preceding an election. A senator must live in the district for at least one year prior to election. Senators are elected for four-year terms, with half the Senate elected every two years.

A representative must be at least 24 years old, a citizen of Kentucky, and must have lived in the state for at least two years and in the district for one year prior to election. Representatives are elected for two-year terms, with the entire House elected every two years.
